## **Volunteers needed to fight the Spotted Lanternfly (SLF) by placing sticky bands on *Ailanthus altissima* (Tree-of-Heaven)**

Since 2015, the Pennsylvania Department of Agriculture (PDA) has been working with citizen volunteers in the SLF quarantine area. Working on their own property, volunteers place sticky bands on the tree-of-heaven throughout the summer and report how many SLF are captured.



### **The PDA and the Penn State Extension welcome returning and new volunteers to the tree-banding program for 2018.**

In 2018, the PDA will work in close conjunction with the Penn State Extension offices, in each county of the quarantine zone (which includes Berks, Schuylkill, Carbon, Monroe, Northampton, Lehigh, Bucks, Montgomery, Philadelphia, Delaware, Chester, Lancaster and Lebanon counties), to help residents control spotted lanternfly nymphs on the tree-of-heaven on their own properties. **Please note that the banding materials supplied through this program are only to be used on tree-of-heaven trees. Citizens who wish to band other species of trees may do so by purchasing commercially available bands.**

#### **• *What work will the volunteers do?***

The bands may be placed as early as the last week of April, but no later than mid-May. Volunteers must change the bands every 2 weeks and enter the number of SLF captured on each band into the PDA's database: PaPlants. This data is important to the PDA and to other agencies to determine allocation of funds for future control efforts. This data also helps demonstrate the effectiveness of tree-banding.

One drawback of using sticky bands is that they can capture other creatures. Other insects are often caught, and some of them may be beneficial insects. Occasionally a bird (such as a woodpecker), small mammal (such as a squirrel), or other animals have been captured. Think about this possibility and have a plan for how you would react to this situation before using sticky bands.

#### **• *How do volunteers get the banding supplies?***

When you have completed the on-line training and quiz, your results will be emailed to you. Print the quiz results and take them to the county Extension office that you have selected to pick up your bands. Within a few days, you will also receive another email with your banding volunteer number.

**The banding kits for volunteers should be available in your selected Penn State county Extension office starting Monday, April 23, 2018. Please call the office before you come to pick up your kit to make sure it is reserved for you.**

#### **• *How can volunteers get help if needed?***
