

**ORDINANCE NO. 2018-05**

**AN ORDINANCE OF MACUNGIE BOROUGH, LEHIGH COUNTY, PENNSYLVANIA AMENDING CHAPTER 329, VEHICLES AND TRAFFIC, ARTICLE III, PARKING REGULATIONS, BY ADDING PARKING RESTRICTIONS ALONG VILLAGE WALK DRIVE IN SECTION 329-29.A.**

*WHEREAS*, Borough Council, after a public hearing, duly advertised, has concluded that it is in the best interest of the Borough to restrict parking along Village Walk Drive to passenger cars and light trucks only.

**NOW, THEREFORE**, upon consideration of the evidence presented at the public hearing, Macungie Borough Council hereby ordains as follows:

**ARTICLE I.**

Chapter 329, Vehicles and Traffic, Article III, Parking Regulations, Section 329-29.A, of the Code of Ordinances of Macungie Borough is hereby amended by adding the following new special purpose parking zones along both sides of Village Walk Drive:

<b>Street</b>	<b>Side</b>	<b>Portion</b>	<b>Days</b>	<b>Hours</b>	<b>Special Parking Purpose</b>
Village Walk Drive	Both	Entire length	Every day	All times	Passenger Car and Light Truck only; No Medium or Heavy Trucks and/or Truck Tractors or Trailers

**ARTICLE II.**

The proper authorities of the Borough are authorized and directed to erect the appropriate parking restriction and information signs and/or markings relating to the regulations established by this Ordinance, and to do so in conformity with the provisions of the Pennsylvania Vehicle Code.

**ARTICLE III. REPEALER.**

All ordinances or parts of ordinances that are inconsistent herewith are hereby repealed.

**ARTICLE IV. SEVERABILITY.**

If any section, paragraph, sub-section, clause or provision of this Ordinance shall be declared invalid or unconstitutional by a court of competent jurisdiction, such decision shall not

affect the validity of this Ordinance as a whole or any part thereof other than that portion specifically declared invalid.

**ARTICLE V.        EFFECTIVE DATE.**

This Ordinance shall become effective on the earliest date permitted by law after its adoption.
